Summary Narrative

The suspect was banned from the Chumash Casino on 12-8-10, until 12-8-11. Casino security found the suspect in the gaming area of Chumash Casino property. She was detained and asked to go to the security office so security could contact law enforcement to complete a citizen's arrest for trespassing. As they approached the entry/exit doors, she attempted to leave. She became combative, trying to kick and hit casino staff. She was subsequently taken to the ground. While on the ground, she reached into her left front pants pocket, removed a small clear plastic baggy and threw it on the ground away from her. Security immediately picked the baggy up off the ground. The baggy contained a clear crystal like substance consistent with crystal Methamphetamine. The substance tested presumptive positive for Methamphetamine using a NIK Narcotic Test Kit. This is a violation of 26200(a) PC- Trespassing, 242 PC- Battery, and 11377(a) H&S- Possession of a Controlled Substance.

[REDACTED] was contacted at the Chumash Casino and advised he was on parole. He also displayed signs and symptoms of being under the influence of a controlled substance, a violation of 11550(a) HS. [REDACTED] admitted to using "meth" one day prior. He was arrested and provided a urine sample, which tested presumptive positive for amphetamines. [REDACTED] was transported and booked into Lompoc Jail.
